GENERAL REPORTS

Executive Director Report (Valerie Brolin)

Ms. Brolin reported and opened discussion on the Teachers and First Responders Resolution. It was decided that the Teachers and First Responders Resolution be amended to add the following changes: The initial amount to start the program is \$100,000 with a cap of 500,000, the end date for the program is December 31, 2019, add Section 4. Executive Director can bring case by case basis to the Board for approval, and on Exhibit B change K-12 to Pre-K-12.

The following resolution was offered by Mr. Frank Muscarello, and seconded by Mr. Lynwood Allemore:

A resolution of the Jefferson Parish Finance Authority authorizing a grant to teachers and first responders to assist the purchase of their principal residence located in Jefferson Parish, Louisiana and financed through the SMAP or LAP program of the Authority; and other matters in connection therewith.

WHEREAS, the Board of Trustees (the "Board") of the Jefferson Parish Finance Authority (the "Authority") in order to provide additional assistance for qualified Teachers (defined below) and First Responders (defined below) and to further stimulate home ownership in Jefferson Parish, Louisiana (the "Parish) desires to provide a grant of \$2,500 (the "Grant") to Teachers and First Responders to assist the purchase of their principal residence in the Parish in connection with mortgage loans financed by the Authority in its SMAP or LAP program (collectively, the "MAP Programs");

WHEREAS, the Grant will be made available with a \$100,000 contribution of the Authority and will be available to qualified Teachers and First Responders in the MAP Programs through December 31, 2019;

WHEREAS, the Executive Director may allocate additional \$100,000 contributions as needed, not to exceed a total of \$500,000.

WHEREAS, the property in connection with the mortgage loan financed by the Authority must be located in Jefferson Parish and occupied as the primary residence of the borrower(s);

WHEREAS, you are a First Responder eligible to participate as (i) a law enforcement officer if you are employed full-time by a law enforcement agency of the federal government, a state, or a unit of general local government in Jefferson Parish; and, in carrying out such full-time employment, you are sworn to uphold, and make arrests for violations of, federal, state, parish, or municipal laws and (ii) a firefighter/emergency medical technician if you are employed full-time as a

firefighter or emergency medical technician by a fire department or emergency medical services responder unit of the federal government, a state, or a unit of general local government serving in Jefferson Parish. First Responder is defined by but not limited to this definition. A comprehensive listing of qualifying positions is attached hereto as Exhibit "A;"

WHEREAS, you are a Teacher eligible to participate as a Teacher if you are employed as a full-time teacher by a state-accredited public school (includes charter school) or private school that provides direct services to students in grades pre-kindergarten through 12. Teacher is defined by but not limited to this definition. A comprehensive listing of qualifying positions is attached hereto as Exhibit "B;"

WHEREAS, employment verification is a step in the mortgage lender's qualification process;

WHEREAS, the mortgage lender shall bring any borrower who's occupation is not listed in Exhibit A or Exhibit B to the Executive Director should the mortgage lender feel the occupation falls within the definition of First Responder or Teacher and is simply not listed; and

WHEREAS, the Executive Director shall present these circumstances to the Board for consideration and approval on an individual basis.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Jefferson Parish Finance Authority, acting as the governing authority thereof, that:

- Section 1. This Board does hereby establish an additional Grant in the amount of \$2,500 to qualified Teachers and First Responders.
- Section 2. The Authority shall establish a sub-account of its Residual Account to be designated the Grant Sub-Account and transfer \$100,000 from the Residual Account to the Grant Sub-Account for Grants through December 31, 2019.
- Section 3. The Executive Director may allocate additional \$100,000 contributions as needed, not to exceed a total of \$500,000.
- Section 4. A copy of this resolution shall be provided to all lenders participating in the MAP Programs and Standard Mortgage Corporation, as servicer for the MAP Program.
- Section 5. The Executive Director shall present employment qualification circumstances to the Board for consideration and approval on an individual basis.
