#### **GENERAL REPORTS**

# **Executive/Marketing Director Report** (Lauren Ruppel)

Ms. Ruppel reported that she would like to expound on the communications. There has been an increase in calls received in the office. She has been spending time talking to lenders about their challenges. What obstacles they are facing? Whose applying for loans? Where are they located? She is encouraged by the fact that there is a lot more activity and Spring-buying season could be impacting that. She is starting to join a lot of networking groups and she has been in contact with a lot more lenders and realtors. The Authority has a table at the Greater New Orleans Mortgage Lender Association coming up at the end of April, which is going to put the Authority in the room with an enormous amount of lenders and realtors. She cannot wait to meet them and continue to promote the Authority's programs.

Ms. Ruppel reported that the billboard is set to begin on April 10, 2023, and run through May 7, 2023. The billboard will be digital and located on the Westbank Expressway it faces eastbound traffic it is exposed to motorist crossing the Harvey Canal overpass towards Gretna and Algiers. It is the most common route for residents in this area with access to the Crescent City Connection and downtown New Orleans. With the digital billboard there a maximum of 8 advertiser which means the Authority will get over 13 hundred spots per day and they role 24/7. It's in high traffic areas where traffic begins to slow move or stand still throughout peak time. The impression are the minimum number of people that will see a specific spot in one-week. The location that she picked will generate about 256,000 impressions. The representative that she has been speaking with will give her some examples this week. Billboards will be added to the Communication Log, and she can also see on Google how many visits to the website has been generated. She will email the Board copies of the final artwork.

Ms. Ruppel reported that she attended the Elmwood Business Association meeting. They highlighted the Authority on their Facebook page. Dr. James Grey, Jefferson Parish Public Schools Superintendent he did a presentation, and she was able to meet with him and his team after the event. She has a meeting scheduled with their Human Resources team after Easter. She will be able to get the program information out to the schools by sending emails, fliers, and attending events. She will continue to report on progress and keep the Board updated.

Ms. Ruppel asked that if other Board Members would like to attend the NALHFA Conference to please let her know. She will also set up an itinerary and reach out to the Board Members that are attending.

Mr. Muscarello asked Ms. Ruppel that by the Authority being a public entity is there a way to get some advertisement for "Gratis" or for free. Ms. Ruppel said she knows that the Authority is exempt from sales tax, she will look into it.
