GENERAL REPORTS

Executive/Marketing Director Report (Lauren Ruppel)

Ms. Ruppel reported that she is currently working on the Financial Reports, and they will be available at the next meeting.

Ms. Ruppel informed the Board that there are five meetings left for the remainder of the year. She asks that all Board members complete all online training before the end of the calendar year.

Ms. Ruppel informed the Board that all five public notices were published in the Jefferson Parish Legal Notices. The first publication was on September 27, 2023, and the second publication on October 5, 2023, the deadline for the SOQs is Monday, October 16, 2023. No submissions have been received.

Ms. Ruppel informed the Board that on Wednesday, September 4, 2023, Dr. Gray, Jefferson Parish School Board Superintendent invited her to do a presentation at the Jefferson Parish School Board Meeting. She is planning to attend the school board's Teacher Induction on Saturday, October 14, 2023.

Ms. Ruppel informed the Board that she attended the Economic & Real Estate Symposium on Thursday, October 5, 2023. There were discussions on insurance, underwriting challenges, and economic forecast.

Ms. Ruppel will be attending the Leadership Jefferson tomorrow, October 10, 2023. The agenda is on Civic and Community Engagement and includes a tour of the City of Gretna with Mayor Constant. They will hear from Jefferson Parish President Cynthia Lee Sheng, Councilman Scott Walker, and Councilman Ricky Templet.

Ms. Ruppel informed the Board that she is scheduled to do a presentation on October 18, 2023, at the New Orleans Education of Construction. NOEL and the Home Builders Association are putting on an event at the Metairie library. The topics will include insurance, home warranties, wind mitigation, and roofing.

Underwriters Report (Stifel, Nicolaus & Company) (Sisung Securities)

The Master Trust Indenture is out, along with the Mortgage Origination Agreement, and they are continuing to provide modifications to it to meet the Authority's guidelines and needs. They have conference calls set up for Wednesday, October 11, 2023, to go over some milestones and the timeline. They are hoping to get everything finalized by year-end. They will keep the Board updated.

General Counsel Report -

Ms. Heather Alexis reported that she has been having weekly meetings with Ms. Ruppel by phone to discuss any issue that comes up and address a lot of questions that she may have during those calls. Ms. Alexis reports that she is still working on the Terrytown Pilot Program documents and has started to help with the bond program.
