Ms. Ruppel reminded the Board to complete the online Annual Ethics and Sexual Harassment trainings before the end of the year.

Ms. Ruppel reported that at the last meeting there was a discussion about reserving dates at the Jefferson Parish Library to announce the bond program. The calendar at the Jefferson Parish Library just opened and we should reserve dates for the Bond Sessions.

Financial Advisor Report (Government Consultants of Louisiana)
